Each chapter also has a summary of the law section, which is made up of a succinct recitation of the relevant "black letter" rules from each chapter. Each chapter also includes five multiple-choice review questions. These questions help to reinforce important concepts from the full chapter, as well as helping students enhance their test-taking skills. Finally, each chapter also includes two longer problems for in-depth review.

Additionally, instructors can use these problems in a variety of formats as the basis for more practice-oriented exercises that can help students develop the skills they will need to become effective legal practitioners.
