The current legislation is based on a binary structure between money purchase schemes, which offer no certainty over retirement benefit, and nonmoney purchase schemes, which have traditionally offered salary related pension benefits. The non-money purchase scheme category can

This promise will either refer to all of the benefits (defined benefits), some of the benefits (shared risk), or there will be no promise (defined contributions). Collective benefits are provided on the basis of allowing the scheme's assets to be used in a way that pools risks across the membership.
